I agree that such uses may include education, advocacy, and fundraising. I consent to and authorize, in advance, such use and agree that Ragtag does not have to notify me of such use or providing with other consideration for such use. I waive any rights of privacy and/or publicity I may have in connection with these uses.	en
